NOTICE IS HEREBY GIVEN THAT public hearings will be held by the Rivergrove Planning Commission at or shortly after 7:00 PM on Monday, Sept 19, 2022, via Zoom (see invitation on following page) to consider the following requests:

Request: Type III Conditional Use Permit and Development Permit to construct:

A dock in the WQRA, with a concrete pad and ramp.

Owner/Applicant: Paul and Amy Quiring Location: 19491 Lorna Lane.

The public hearing on this matter will be conducted pursuant to the rules of procedure adopted by the Planning Commission. Oral and written testimony in favor of or in opposition to the request will be received during the hearing. Written comments may be submitted prior to the hearing by mailing to Heather Kibbey, City Manager/Recorder, City of Rivergrove P.O. Box 1104, Lake Oswego, OR 97035 or at manager@cityofrivergrove.com no later than 5 P.M. Sept 14th, 2022. The deci-

sion to approve or deny the application will be based on compliance with the following ordinance criteria:

- -- Rivergrove Land Development Ordinance (RLDO) Article 4 Sec. 4.010-4.110 Review Procedures; Article 5 Sec. 5.010-5.090 Districts and Zones, Sec. 5.020 Flood Hazard District, Article 6 Sec. 6.300-6.330.
- -- Ordinance 70-2001 Rivergrove Flood Ordinance
- -- Ordinance 52 Flood Damage Prevention.

Copies of the application information can be obtained at cost and are available for review by contacting the City Manager/Recorder, at 503-639-6919. Any questions regarding the application should also be addressed to the City Manager/Recorder. A staff report will be available for inspection on or about Sept 12th, 2022 (contact the City Manager/Recorder to see the report or obtain a copy provided at cost).

Issues regarding compliance with pertinent code standards may provide the basis for an appeal to the Land Use Board of Appeals and shall be raised and submitted before the record is closed. Issues must be raised with sufficient specificity to enable the Planning Commission to respond to the issue. Failure to raise an issue in person or by letter, or failure to provide sufficient specificity to afford the decision-maker an opportunity to respond to the issue precludes appeal to the State Land Use Board of Appeals on that issue.

In addition, failure to raise constitutional or other issues relating to proposed conditions of approval, with sufficient specificity to allow the Planning Commission to respond to the issue, precludes an action for damages in circuit court.

The Planning Commission shall review the applications under a Type III procedure and make a decision according to the applicable criteria specified above. This hearing may be continued without additional published notices. All interested persons are invited to attend and be heard.

2. If additional time is available after the hearing, the Commission may devote time to discussing how best to address the proposed new Code. This is not a public hearing, simply a Commission worksession to determine how to proceed.

UPDATE ON THE PLAYSTRUCTURES AND PICNIC TABLES GIVEN TO THE CITY





As River Grove Elementary School neared its deadline for demolition, Mayor Walter Williams asked about the fate of the two beautiful play structures (valued at over \$200,000) and 7 sturdy picnic tables.

As it turned out, they were scheduled for demolition too, even though they were considerably newer than our play structure in Lloyd Minor Park. Mayor Williams asked for them and the school district told him that he was welcome to have them, provided he could remove them before demolition began. He asked both the Planning Commission and Council for their thoughts.

Both indicated they were in favor of saving them!

Thanks to Mayor Williams and a hard-working crew of volunteers, both play structures and all the picnic tables were disassembled, had concrete removed from their bases and were moved to a secure storage facility outside of the City.

All of this was at NO COST to the citizens of Rivergrove.

In January, the City will prepare a formal application to the Planning Commission, to decide what the outcome will be for all of this equipment given to the City. However, in the meantime, the generous gift is free from the wrecking ball.
